**Considering** the Decree issued by the Board of the Research Centre CIRIAF Centro Interuniversitario di Ricerca sull'Inquinamento e sull'Ambiente, on July 1<sup>st</sup> 2019, approving the proposal to establish a 2<sup>nd</sup>-Level Master in "Intellectual Property and Technology Transfer" for the A.Y. 2019/2020, including, as an integral and substantial part, the course project and the Didactic Regulations attached to the present Decree;

**Considering** in the aforementioned course project attached to the present Decree, the members of the Board of Teachers of the Master have been identified in accordance with the provisions included in art. 8 - 2<sup>nd</sup> paragraph of the "Regulations regarding University Master courses and Advanced educational courses";

**Considering** that, on 12<sup>th</sup> July 2019, the Coordinator of the University Performance Evaluation Group has expressed a positive opinion with regard to the establishment and activation of the Master;

**Considering** that the University Board of Governors, at the meeting during the meeting on July 15<sup>th</sup> 2019, has approved the proposal to establish and activate the Master, following a positive feedback from the Academic Senate, provided on the 15<sup>th</sup> July 2019 meeting;

**Considering** D.R. no. 1888 issued on July 19<sup>th</sup> 2019 approving the establishment/activation of the 2<sup>nd</sup>-Level Master in "Intellectual Property and

## **DECREES**

### **Art. 1**

#### ***Extension of terms/Number of participants***

The application process for the admission to the 2<sup>nd</sup>-Level Master in “Intellectual Property and Technology Transfer”, A.Y. 2019/2020, proposed by the Department of Engineering and CIRIAF of the Università degli Studi di Perugia is extended, in accordance with its terms and conditions, **to 31<sup>st</sup> October 2020**.

The aforementioned 2<sup>nd</sup>-Level Master will have a duration of one year and is to be held entirely in English. Courses are to take place in the 2019/2020 A.Y., for a total of 70 educational credits.

The 2nd Level Master in Intellectual Property and Technology Transfer of the University of Perugia has the main goal of promoting a specialized training for Technology Transfer Managers.

This qualification is addressed to those graduates that are interested in a postgraduate diploma in Intellectual Property and technology Transfer with focus on industrial and intellectual property law, economics, finance and ethics of innovation.

The knowledge gained after completing the course is multidisciplinary and concerns Patents, Trademarks and designs, Plant varieties and geographical indications, Copyright, know-how, transfer and licensing of intellectual property rights, Intellectual property systems and process of granting, Digital innovation, History and Anthropology of Innovation, Innovation finance and proof of concept, Business planning of a technology start-up, Corporate finance for start-ups, Sustainability as an innovation tool, Ethics and technology transfer, innovation ecosystems.

The Master will count on professorship from EUIPO, the European Intellectual property Office, as well as on specialized lawyers and professors who are experts in the field, both Italian and foreign, and experts from public institutions in the field of innovation. The educational profile is completed by internships in highly innovative companies and prestigious institutions dealing with intellectual property and technology transfer.

A tutoring service will support management and teaching activities (1 tutor every 5 students).

**Participation in the course is limited to a maximum of 25 students.**

**The minimum number of participants is 15.**

**Art. 2**  
**Admission requirements**

A Post Graduate degree obtained abroad in similar fields of study can be accepted, under the condition that said degrees be recognized as valid, adequate and pertinent based on the laws and regulations currently in force.

Furthermore, the Board of Professors can admit graduates with degrees from other classes, following a thorough evaluation of the educational programs, that have been deemed adequate on the basis of the admission procedures.

**All applicants** (art. 39, paragraph 5, D.Lgs. 286/98, modified by art.26 of Law n. 189 - 30/07/2002), **who have foreign academic qualifications**, must submit the certification directly to this University together with the application, along with the official and notarized translation in Italian with the pertinent "Dichiarazione di Valore" (Declaration of Academic Value) issued by the Italian Consulate or Diplomatic Representation in the country where the degree has been awarded.

Candidates can also hire local translators and have the translation notarized by the competent Italian Consulate or Diplomatic Representation. If in Italy, they can contact the local Court or official translators.

**The registration fee is € 6600.00, (plus € 16,00 for stamp duty) to be paid in three installments:**

- **candidates must pay the first installment of € 2500.00 during registration;**
- **the second of € 2500.00 within 3 months from the beginning of the course;**
- **the third of € 1600.00 within 6 months from enrollment.**

**Art. 3**  
**Admission applications**

The application to the Call, on the provided form (**duly legalised with a €16,00 revenue stamp**) as a Self Certification/Self-Declared Affidavit, in accordance with art. 46 and 47 of D.P.R. 445/2000, by using the attached form (Annex "A"), duly filled out and signed (handwritten signature), including all the required documentation (failure to comply will result in exclusion of the candidate) must be sent to the Magnifico Rettore of the University of Perugia - Piazza dell'Università n.1 - 06123 - Perugia and **must arrive, on penalty of exclusion, by the final deadline: 31st October 2020.**

In the application, filled out using the form included in Annex "A", candidates must declare:

- his/her personal data and address;

- the possession of the degree required for admission to the Master, in accordance with art. 2 of the present Call;

- his/her citizenship;

- that he/she has full political and civil rights as well as possessing an adequate knowledge of the Italian language (only for foreign EU or Non-EU citizens);

- that he/she gives full consent, should the Administration receive motivated request to access the records and official documents regarding the present procedure and the undersigned is the person against whom the request is

made, to being sent in digital form via email, at the email address indicated in the present application, in accordance with article 3 of the D.P.R. 184/2006, of the copy of the access request withstanding the possibility to challenge, with a rightful motivation, said request, also by email, within 10 days after having received the afore-mentioned communication; - that he/she accepts all of the terms and conditions included within the Call for Applications.

- whether or not he/she possesses an officially recognized disability or Specific Learning Disability. Those candidates who have a recognized disability, in accordance with Law 104/1992 and subsequent modifications and integrations, and those who, with reference to their disability, require specific equipment or aids during the test, as well as candidates affected with specific learning disabilities, according to Law 170/2010 must specify in their applications the type of disability by which they are affected and the specific required aid, also by attaching, whether in original or notarized copy, suitable documentation stating the official recognition of the disability by the official authorities in charge. Candidates with certified Specific Learning Disabilities are granted a 30% additional time when taking the admission tests. **Failure to comply with the aforementioned specifications will result in the relinquishment/loss of all benefits. To avoid exclusion** the application must be signed (handwritten signature) without notarization, in front of the appointed clerk at the moment of submission or signed (handwritten signature – no notarization of the signature is required) and presented along with a photocopy of a currently valid identity document. - b) receipt of payment of € 60,00 as well as receipt of payment of €16,00 (if applicable in order to fulfil foreign candidates’ obligation to apply a Revenue stamp to the application);**
- c) curriculum vitae (Resume),** filled out using the attached Model “B”;
- d) documentation attesting the recognition of the disability to be produced in the above-mentioned forms**

**Please note:** In order to properly fill out the application and to submit the required documents for admission to the present selection as well as to evaluate the candidate’s qualifications, all Self-Certification Statements, in accordance with art. 46 of D.P.R. 445/2000 (with which personal status, qualities and the listed facts, in strict accordance to art. 46, can be declared) as well as Self-declared Affidavits in accordance with art. 47 of D.P.R. 445/2000 (with which

personal status/data and facts that the candidates are aware of can be declared as well as the conformity of the photocopy with the original of a document, a publication, an academic degree, or a service certificate) can be validly submitted in accordance with art. 3 of D.P.R. 445/2000, by Italian citizens and by citizens of the European Union; citizens of countries outside the European Union who are legally residing in Italy can use Self-Certification Statements and Self-Declared Affidavits in accordance with articles. 46 and 47 limitedly to the countries, personal qualities and certifiable (or verifiable by Italian public officials) facts, provided that the laws or regulations regarding immigration and that the condition of the foreigner do not state otherwise and also that the use of the Self-certification Statements and Self-Declared Affidavits be authorized through international agreements between Italy and the country of origin and within the limits and terms of these conditions.

#### **Art. 4** **Selection procedures**

**The Board of Professors will nominate a Selection Commission for the selection of candidates.** The selection is based on qualifications and an interview. The interview is evaluated with a maximum of 10 points. The admissible qualifications are evaluated with a maximum of 10 points.

#### **Admissible qualifications and criteria are as follows:**

##### **a) Graduation mark, as follows:**

up to 102	2 points
from 103/110 to 109/110	3 points
110/110	4 points
110/110 Summa cum laude	5 points

**b) Publications relating to Intellectual property and technology transfer:** 2 points maximum;

**c) previous professional experience relating to intellectual property and technology transfer:** 3 points maximum.

Evaluation and verification of qualifications, following the formulation of the pertinent criteria, are to be performed by the Selection Commission.

Before the interview, the Commission will communicate to each candidate the result of the evaluation of the qualifications.

The interview that will be considered passed if the candidate reaches the minimum score of 6 points will focus on the following topics:

- knowledge of the English language;
- interview on the candidates motivations to enroll.

The interview will take place on **12<sup>th</sup> November 2020**, starting at 9:30, CIRIAF Office, at the Department of Engineering of the University of Perugia – 1<sup>st</sup> floor, CIRIAF Building, Via G. Duranti 65, 06125, Perugia.

To be eligible for the interview, candidates must have one of the following identification documents: identity card, passport, driving license, or other identity cards, provided they show a photograph and a stamp or other equivalent signature, and were issued by a State administration. The aforementioned documents must not have expired.

**Enrolment**

**The enrolment fee for this Master has been determined to be € 6.600,00**, six thousand and six hundred Euros, (add € 16,00 for stamp duty) to be paid in three installments:

**Educational activities – Correspondent credits**  
**Attendance**

The duration of the course, for the awarding of the Master Degree, is **1750 hours**, distributed as follows:

- 600 hours for frontal lessons and, if applicable, e-learning module and interactive and assisted videoconference;
- 975 hours for individual study and final essay;
- 175 hours for the participation to the internship.



**Following the fulfilment of the objectives and the acquisition of the required knowledge, as well as of the pertinent operational and relational abilities, the acquisition of 70 university educational credits is awarded.**

In particular, the allocation of the educational credits is as follows:  
60 educational credits for frontal educational activity, assisted and laboratory activity as well as individual study;  
3 credits for the essay and final test;  
7 credits for the internship.  
No credits will be awarded for examinations that have been taken during the student's previous academic career.

At the end of the course, candidates who have fulfilled both the formal and the substantial duties will have to take, in front of a Commission, a final test, consisting in the discussion of a written essay.

Those candidates who successfully pass the final examination will be awarded the University Degree title of 2nd-Level Master in "Intellectual Property and Technology Transfer", signed by the Rector of the Università degli Studi di Perugia, as well as being awarded 70 CFU.

The 7 educational credits pertinent to the internship, along with the 3 awarded for the Master's thesis, can be acquired at partner institutions, in accordance with Law no. 196 of 24.6.1997 and with the Decree implementing Law no. 142 of 25.3.1998.

Students must mandatorily attend a minimum of 75% of the lessons, laboratory and internship activities. Awarding of the credits is dependent on the verification of the acquired competences as well as of attendance. The student's hours of absence cannot be cumulated in a single module. Those students who do not meet the attendance requirements or who have not taken the final examination within the date fixed by the Board of Professors will not be awarded the Degree.
