## **Rector's Decree**

#### The rector

Given Law No. 341 of November 19, 1990;

**Considering** Law No. 240 of December 30, 2010, and subsequent amendments, concerning the organization of Universities, academic staff, recruitment, as well as delegation to the government to incentivize the quality and efficiency of the University system, particularly Article 22, paragraph 1;

**Considering** Legislative Decree No. 17 of January 9, 2008, "Implementation of Directive 2005/71/EC on a specific procedure for admitting third-country nationals for the purposes of scientific research";

**Considering** the note from the Ministry of Education, University, and Research (MIUR) protocol number 583 of April 8, 2011;

**Considering** Ministerial Decree No. 102 of March 9, 2011, which establishes the minimum gross annual amount for the award of research fellowships;

**Considering** the Statute of the University of Perugia issued by Regional Decree No. 889 of May 28, 2012, published in the Official Gazette on June 21, 2012, and subsequent amendments:

**Considering** the decree-law No. 192 of December 31, 2014, and in particular Article 6, paragraph 2-bis, converted into Law No. 11 of February 27, 2015;

**Considering** the University Regulations for Research Fellowships issued in accordance with Law No. 240 of December 30, 2010, by Regional Decree No. 692 of March 23, 2022; **Considering** Decree Law No. 198 of December 29, 2022, converted into Law No. 14 of February 24, 2023;

#### **Article 1**

Number of positions

A public competition is announced (open position notice), based on qualifications and interview, for the allocation of 1 research collaboration post-doc fellowship - SENIOR type - as specified in Annex No. 1, which is an integral and substantial part of this decree. The fellowship may be extended, if applicable, according to current regulations.

#### Article 2

## **Admission Requirements and Eligibility Rules**

Individuals with a suitable scientific-professional curriculum for conducting research activities, and holding a bachelor's degree (a course of study lasting at least 4 years, as provided for in the educational regulations prior to Ministerial Decree No. 509 of November 3, 1999), specialist degree (Article 3, paragraph 1, letter b), Ministerial Decree No. 509 of November 3, 1999), or master's degree (Article 3, paragraph 1, letter b), Ministerial Decree No. 270 of October 22, 2004), as specified in Annex 1, point 1), obtained at least 5 years ago, and a doctoral degree as specified in Annex 1, point 2), are eligible to apply for participation in the competition to be eligible for this open position.

Those who have a kinship or affinity relationship up to the fourth degree, with a professor belonging to the department requesting the activation of the fellowship, or with the Rector, the General Director, or a member of the Board of Directors of the University, are not eligible to participate in the selection process. Personnel who hold a permanent position in the entities referred to in Article 2, paragraph 3 of the current Regulations for Research Fellowships cannot hold a research fellowship.

The prescribed requirements must be met, under penalty of exclusion, by the deadline for submitting the application for admission to the selection.

The administration ensures equal opportunities for men and women in access to employment and in the treatment at work, in accordance with Law No. 125 of April 10, 1991, "Positive Actions for Achieving Gender Equality in the Workplace".

The application for admission to the selection must be submitted, under penalty of exclusion, within a non-extendable period of **15** days starting from the day following the publication of this notice on the online bulletin board of the University of Perugia. The application must be written on plain paper using the "A" model attached to this notice and duly signed by the candidate. It should be addressed to the Magnificent Rector of the University of Perugia, Piazza Università, 1 - 06123 Perugia.

If the deadline falls on a Saturday or a public holiday, the deadline is postponed to the next working day.

Applications received after the deadline for submitting the application, as indicated in paragraphs 1 and 2 of this article, are excluded, even if they were sent within the aforementioned 15-day period.

The application and the relevant documentation must be submitted exclusively in one of the following ways:

- Personal details, date and place of birth, citizenship, residence, certified email address or regular email address to which the candidate, under their own responsibility, declares to receive all communications related to the competition procedure specified in this call for applications, as well as a contact telephone number.
- 2) Possession of the academic degree specified in Annex 1, point 1), obtained at least 5 years prior to the date of application for participation in the public selection.
- 3) Possession of the doctoral degree specified in Annex 1, point 2).
- 4) Possession of a professional scientific curriculum suitable for conducting research activities.
- 5) Any qualifications that entitle to preference in case of equal merit, subject to nonevaluation as specified in the subsequent Article 7, possessed by the deadline for the submission of applications for the selection.
- 6) The number of years in which Italian research fellowships have been received in accordance with Law No. 240/2010, excluding the period during which the fellowship was awarded in conjunction with the doctoral program without a scholarship.
- 7) Not having a degree of kinship or affinity up to the fourth degree inclusive with a professor belonging to the Department requesting the activation of the fellowship or with the Rector, the General Director, or a member of the Board of Directors of the University.

Candidates who have been recognized as disabled according to Law No. 104/1992 and subsequent amendments and integrations, and who require specific support during the examination due to their disability, as well as candidates with Specific Learning Disorders according to Law No. 170/2010, must declare in their application the type of disability/disorder and the assistance required for the examination. They must attach suitable documentation, in original or authenticated copy, attesting to the recognition of the disability by the competent authorities. Candidates with certified Specific Learning Disorders are granted an additional time equal to thirty percent more than the defined time for the admission tests of other candidates.

# The following documents must be included into the application package:

a. Scientific-professional curriculum vitae, demonstrating the possession of the required skills specified in Annex 1, for the assessment by the Evaluation Committee of suitability for conducting research activities in accordance with Article 3, point 1 of the Research Fellowship Regulations. accompanied by a self-certification declaration or an act of notoriety, using Form B, stating "that the information provided in the Curriculum Vitae is true";

- b. Candidates with foreign academic degrees must attach to the application the degree certificate accompanied by a translation in Italian or English and a declaration of conformity to the original of the translation, to be made using Form A1, and if applicable, the declaration of equivalence;
- c. Photocopy of a valid identification document. If the applicant does not possess a valid identification document, the applicant's status, personal qualities, and the facts contained therein can be proven by presenting the document, provided that the applicant declares, at the bottom of the photocopy of the document, that the data contained in the document have not changed since the date of issuance;
- d. Self-certification declaration/act of notoriety (Form B);
- e. Any scientific publications;
- f. Any documentation attesting to the recognition of disability/SLD.

The Annex A form, Annex A1 template, and Annex B must be signed with a handwritten or digital signature, under penalty of exclusion.

The candidates also undertake to:

For the correct preparation of the application and the production of the documentation attached to the application, it is specified that self-certification statements in accordance with Article 46 of Decree Law 445/2000 (which can declare states, personal qualities, and facts specifically listed in Article 46) and statements of notoriety in accordance with Article 47 of Decree Law 445/2000 (which can declare states, personal qualities, facts known directly by the declarant, and that the photocopy of a document, publication, academic degree, or service title is a faithful copy of the original) can be validly made, in accordance with Article 3 of Decree Law 445/2000, by Italian citizens and citizens of the European Union. Non-European Union citizens regularly residing in Italy can use self-certification statements according to Articles 46 and 47 only for states, personal qualities, and facts certifiable or attestable by Italian public bodies unless the use of the aforementioned self-certification statements is permitted by international agreements between Italy and the country of origin, within the limits of such provisions.

Candidates are admitted to the selection with a reservation. Exclusion for the reasons stated in this announcement may be imposed by the Administration at any time during the procedure and will be notified to the interested party.

### Article 4

## **Evaluation Committee**

The Evaluation Committee is appointed by Rector's Decree in accordance with Article 13, paragraph 1 of the Regulations for research fellowships at the University of Perugia.

### **Article 5**

### **Evaluation of Curriculum and Qualifications**

- 1. The Committee first proceeds to define the evaluation criteria for qualifications and the interview. Subsequently, the Committee examines the curriculum vitae of each candidate to verify their suitability for research activities by assessing the possession of the required skills listed in Annex 1.
- 2. The Committee evaluates the qualifications based on the previously identified criteria.
- 3. For the awarding of SENIOR research fellowships, a maximum score of 60 is reserved for qualifications, and a maximum score of 40 is reserved for the interview. Candidates who have obtained at least 30 out of 60 points overall for

qualifications and at least 20 out of 40 points overall for the interview are considered eligible.

The qualifications to be evaluated will be those declared by the candidate in the curriculum vitae attached to the application or produced according to the methods indicated in the previous Article 3.

Failure to attach any publications accompanied by a self-certification of certification oraffidavit of authenticity, using the Annex B template, will result in non-evaluation of the candidate.

Article 6

**Examination Test** 

The examination test consists of an interview conducted via video conference. The interview will focus on assessing the required skills listed in Annex 1 and verifying knowledge of the English language.

To be admitted to the interview, the candidate must be in possession of one of the following identification documents: identity card, passport, driver's license, nautical license, pension booklet, license for the operation of thermal plants, firearms license, identification cards, provided they have a photograph and stamp or equivalent signature, issued by a government authority.

The aforementioned documents must not have expired as per the validity period specified for each of them.

If the person possesses an identity or identification document that is not currently valid, the states, personal qualities, and facts contained therein can be verified by presenting the document itself, provided that the individual declares, at the bottom of the photocopy of the document, that the data contained in the document have not changed since the date of issuance.

#### Article 7

### Preferences in case of equal merit

The qualifications that entitle to preference, in case of equal merit, are as follows:

- The degree of Philosophy Doctor (Ph.D) or an equivalent degree obtained abroad, provided it is relevant to the scientific field to which the grant refers, or for the

relevant sectors, a specialization degree in the medical field (if not required as an admission requirement).

- Younger age.

The preferred qualifications must be declared in the application, failing which they will not be evaluated, and must be submitted within the deadlines for submitting the application for participation in the selection, attached to the application on plain paper, in the original or authenticated copy, or in accordance with the provisions of Presidential Decree No. 445/2000 through the attached declaration (Annex B).

**Article 8** 

Elaboration, approval, and publication of the merit rankings

Upon completion of the oral examination, the Evaluation Committee provides an overall evaluation for each candidate and compiles a merit ranking based on the sum of the scores obtained, identifying the winner based on the final ranking and the number of grants advertised.

The merit ranking is published on the notice board of the University of Perugia and will remain posted for 60 days after its publication. No personal communications will be sent in this regard.

The winners who are successfully placed in the ranking must sign the corresponding contract.

procedure?view=concorsi, in compliance with the provisions on transparency, evaluation, and merit.

The research activity will commence from the date indicated in the contract.

Article 9

Incompatibility and prohibition of multiple simultaneous contracts

1. These Grants (post doc research fellowships) cannot be combined with remuneration derived from any type of subordinate employment, or with other scholarships of any kind, except those granted by national or foreign institutions to complement the research activity of the grant holders with stays abroad.

- 2. The holder of the research grant (post doc) cannot be enrolled in degree courses, specialist or master's degrees, university master's programs, or research doctorates with a scholarship or medical specialization, in Italy or abroad.
- 3. The holders of the research grant (post doc) who are employed by public administrations are placed on leave without pay.
- 4. The research grant (post doc) is compatible with teaching contracts at the University.
- 5. The research grant (post doc) is compatible with attending research doctorate courses without a scholarship in scientific-disciplinary sectors related to the research activities connected to the grant, provided that such attendance is authorized by the Director of the Department or Structure, upon favorable opinion of the Scientific Supervisor of the research.
- 6. Holders of research grants (post docs) in experimental and clinical medical sciences, in accordance with the needs related to their research activity and compatible with it, may also carry out healthcare activities, upon reasoned proposal of the Department or Structure, after consulting the Scientific Supervisor of the research and formal agreement between the University and the relevant healthcare facilities.
- 7. In accordance with the research tasks assigned to them, research fellows may, with the prior written authorization of the Scientific Supervisor, participate in research and consultancy activities on behalf of third parties commissioned by the University in accordance with Article 66 of Presidential Decree 382/80, and distribute the related proceeds according to the procedures established by the current regulatory provisions.

All suspension measures are issued by Rector's Decree.

#### Article 10

### Relationship between research fellow and University

The research fellowship payment is made in monthly arrears. Research fellows carry out research activities in accordance with the program outlined in the call, fulfilling the tasks and performing the functions specified therein.

Research fellows have the right to use the facilities and equipment of the unit where they carry out their activities for the purpose of conducting their research activities and to benefit from the services available to researchers according to the rules in force in that unit.

Engaging in research activities outside the department or unit that proposed the award of the fellowship must be authorized in advance by the Director of the respective unit, in consultation with the Scientific Supervisor.

Research fellows who spend periods away from the university with the consent of the Scientific Supervisor and authorization from the Department Director or the relevant unit are entitled to the mission benefits provided by the University for doctoral students. Research fellows, subject to the authorization of the Department Director or the relevant unit in agreement with the Scientific Supervisor, can submit research projects of the University of Perugia and assume scientific responsibility for them, provided that the duration of these projects is equal to or shorter than the natural duration of the research fellowship, excluding renewals and extensions, and provided that such activity is compatible with the obligations arising from the research activity associated with the fellowship they hold. In anticipation of the expiration of the contract's duration, the fellowship holder must prepare a report on the activities carried out, co-signed by the Scientific Supervisor and accompanied by any publications, including those in progress, patents, and any other relevant material for the evaluation of the conducted research, and submit it promptly to the Department Council or the unit that proposed the award of the fellowship.

The mandatory maternity leave and leave due to illness or injury of the research fellow do not terminate the employment relationship, which remains suspended without payment, subject to the maternity benefits provided for by Article 5 of the Ministerial Decree of Labor and Social Security of July 12, 2007, and the sickness benefits provided for by Article 1, paragraph 788, of Law No. 296 of December 27, 2006. The suspension of the contract in the aforementioned cases results in an extension of the contract duration equal to the period of suspension. During the mandatory maternity leave, the allowance paid by INPS in accordance with Article 5 of the aforementioned Decree of July 12, 2007, is supplemented by the University up to the full amount of the research fellowship.

The industrial property rights to the results achieved by the research fellow on behalf of the University in the course of their research activities are subject to the provisions of the University's current regulations on industrial and intellectual property at the time of obtaining the results.

Article 11 Ending the contractual relationship



- 1. The University is entitled to terminate the contract, thereby dissolving the corresponding relationship with immediate effect, if the holder of the grant:
- a) Unjustifiably fails to commence the research activity;
- b) Unjustifiably suspends the research activity for a period exceeding ten days;
- c) Unjustifiably fails to fulfill the specific research tasks specified in the call or repeatedly exhibits serious negligence in carrying out these tasks;
- d) Engages in any of the incompatibility cases referred to in Article 8, paragraphs 1 and 2, or in Article 3, paragraphs 2, 3, and 4, or if it emerges that, at the time of establishing the contractual relationship, there was any of the incompatibility cases referred to in Article 8, paragraphs 1 and 2, or in Article 3, paragraphs 2, 3, and 4.
- 2. The University is entitled to terminate the contract with immediate effect if the suspension of the contractual relationship resulting from the illness or injury of the grant holder persists for a period exceeding one-sixth of the total duration of the contract established by the agreement.
- 3. Department Council or the Structure that proposed the grant.
- 4. The grant holder (post doc) may terminate the contract at any time by providing a written notice of at least thirty days to the Rector. Failure to comply with this deadline will result in the deduction of an amount equivalent to the compensation due for the unperformed notice period.

The grant holder who intends to terminate the contract is required to notify the reference Structure and the Competition Office at least 30 days in advance.

### Article 12

## Treatment of personal data

In accordance with Legislative Decree no. 196/2003 and EU Regulation 2016/679, personal data provided by candidates will be collected at the University of Perugia for the purpose of managing this procedure and will be processed in an automated database.

The provision of such data is mandatory for the evaluation of participation requirements, failing which the candidate will be excluded from the selection.

Candidates are entitled to the rights provided by Legislative Decree no. 196/2003 and EU Regulation 2016/679, in particular, the right to access their personal data, request their rectification, updating, and deletion if incomplete, inaccurate, or collected in violation of
