The interview may, at the candidate's choice, be held in English.

**Evaluation of qualifications and research project and interview (in 60s: 30+ 30)**

**Evaluation of the qualifications,** In addition to the university training course, as well as any further training and professional and research experience and any specific scientific publications in relation to the doctorate, the evaluation of the qualifications will also include the preparation, by the candidates, of a research project of their choice, lasting three years, aimed exclusively at evaluating the candidate on one of the topics into which the doctorate is divided or on the specific topic to which the scholarship with a reserve for company employees is linked. The committee reserves the right, however, to match scholarships and candidates on the basis of the profile as it emerges from the qualifications submitted, the individual scholarship reserves or other reserves (company employees) of the project and the interview. The overall evaluation, in thirtieths, is accompanied by details of the awarding of marks.

The research project presented may, at the discretion of the committee, be awarded a score of up to a maximum of 15 points in order to avoid young graduates being denied access to the interview. It should be noted that only titles consistent with the themes of the PhD or of methodological interest to the PhD itself will be assessed. With a score below 18, it will not be possible to take part in the interview. The committee may admit to the interview only research projects and a coherent degree. Scoring criteria for the qualifications and the research project

**University course of study, up to a maximum of 4 points,** awarding the following **points** to the degree grade (where the committee considers the degree to be coherent)

Grade of 110/110 cum laude and 110/110: points 4

Grade of 109/110 to 107/110: points 3

Grade from 106/110 to 104/110: 2 points

Grade from 103/110 to 100/110: 1 point

Grade below 100/110 or inconsistent degree: 0 points

For candidates who obtain the qualification required for admission after the deadline of the call for applications, for whom it is not possible to assess the degree grade, the curricular average of the examinations taken will be assessed, awarding up to a maximum of 4 points, according to the scheme related to the degree grade previously reported; for this purpose the curricular average grade, multiplied by 110 and divided by thirty, is rounded to the unit.

**Further training and professional and research experience:** only professional and research experience and training courses that are relevant to the research pathway envisaged by the doctorate will be assessed. The experiences or training courses must also be correctly declared and documented by the candidates and must not be of less than six months' duration. **Up to a maximum of 11 points are awarded** for further training and relevant professional and research experience, acknowledging:

- up to 3 points for each experience in scientific research in areas related to reading education, reading promotion, evaluation of the effects and

benefits of reading and reading aloud, experimental research related to reading (research grants, research scholarships or fellowships for research projects, structured and documentable research collaboration will be evaluated) or research experience, in any case related to the humanities, which is of particular interest in terms of methodology; up to 3 points for each experience of more than 6 months;

- up to 2 points for each professional experience in the field of reading didactics which is specific and not generic only if relevant (e.g. continuous and not occasional experiences in the animation of reading groups, training of educational staff on reading, systematic meetings on reading, organisation of systematic didactic activities supporting reading aloud, reading promotion, reading education will be considered relevant, while experience teaching Italian language and literature in the education system will not be considered relevant): 2 points for each different experience, each lasting more than 6 months. This area may reach a total of 9 points;

- up to 1 point for each additional training course specifically related to reading, reading education, narrative methods, research in the qualitative or quantitative human sciences (such as: 1st and 2nd level master's degree, relevant specialisation, other documented courses, with final examination and certification and lasting more than 6 months): up to 1 point for each course, for a maximum of 2 points.

**Publications** - Points will be attributed to any publications, only if made available by the candidates and if consistent with the themes of the doctorate, **up to a maximum of 4 points** for publications relevant to the above-mentioned themes, awarding

- to each publication of very good quality, in terms of scientific depth and editorial relevance, 2 points;

- to each publication of good quality, in terms of scientific depth and editorial relevance, 1 point;

- 0.5 points for each publication of sufficient quality, in terms of scientific depth and editorial relevance.

**Research project** Points will be awarded to research projects produced in conjunction with the application: **up to a maximum of 15 points**, recognising

- the research project of excellent quality, in terms of scientific depth and research aptitude, up to 15 points;

- to the research project of good quality, in terms of scientific depth and research aptitude, up to 11 points;

- to the research project of sufficient quality, in terms of scientific depth and research aptitude, up to 8 points).

Lower marks will be awarded for insufficient projects.

– the pass mark for the interview is 22 (the sum of qualifications and interview must in any case be 40 or above)

The interview will focus on questions put to the candidates on the topics of the doctorate with technical and methodological insights. The interview will also be aimed at verifying the candidate's aptitude for research, willingness to carry out experiences abroad and in the field, and scientific interests. A maximum score of 30 points is reserved for the interview; **it will be considered passed if an overall mark of no less than 22/30 is obtained.**

– for each professional experience in the field of teaching (tutoring, supporting teaching activity, supplementary teaching activity, teaching contracts in public or private university institutions) relevant: 0.5 points up to a maximum of 1 point  
– for each professional experience in the field of scientific research (research grants, scholarships for research projects, participation with responsibility in archaeological excavation campaigns) relevant: 0.5 points up to a maximum of 1 point;  
– for each additional educational pathway (relevant 2nd level master's degree, relevant specialisation, relevant qualification, participation in relevant congresses as speaker, diploma of archivist obtained at state archives, double degree in Italian and foreign courses of study, additional degree with respect to the one valid as access title to the present procedure, awards and recognitions for relevant research activity): 0.5 points up to a maximum of 1 point

**Publications, up to a maximum of 3 points** for relevant publications, awarding

– to each publication of very good quality, in terms of scientific depth and editorial relevance, 3 points  
– to each publication of good quality, in terms of scientific depth and editorial relevance, 2 points;  
– to each publication of sufficient quality, in terms of scientific depth and editorial relevance, 1 point.

**Research project, up to a maximum of 9 points**, awarding

- to the research project of distinguished, very good or excellent quality, in terms of scientific depth and research aptitude, from 7 to 9 points;
- to research projects of fair, good or very good quality, in terms of scientific depth and research aptitude, 4 to 6 points;
- to the research project of just sufficient, sufficient or more than sufficient quality, in terms of scientific depth and research aptitude, from 1 to 3 points;
- To the research project of insufficient quality, in terms of scientific depth and aptitude for research, or not relevant, 0 points;

**The interview** will focus on the subjects of the curricula in which the doctorate is divided.

The interview will be aimed at also to verification of the aptitude to research, the candidate's willingness to gain experience abroad and scientific interests.

Finally, an integral part of the interview will be the discussion of the research project presented by the candidate.

At the candidate's choice, the interview may be held in English.

The interview will be considered successful if an **overall mark of no less than 21/30** is obtained.

The criteria for the assessment of the interview are as follows: knowledge of the subject; clarity of exposition; aptitude for research; willingness to carry out experiences abroad and the candidate's scientific interests.
