Cristina Montesi graduated in Economics with full marks and honours at University of Perugia (Italy) and at the present is confirmed researcher in *Economic Policy* at the Department of Economics of the University of Perugia, where she has been working since 2002, after many years of scientific activity at Irres (The Regional Institute of Economic and Social Research of Umbria District-Italy) as junior and then senior researcher.
