

Enrico Carloni (1971), is full professor of administrative law, University of Perugia, Department of Political Science. Since 2008 to 2018 he was associate professor of administrative law at the University of Perugia. Lawyer of the Perugia Bar (special register of university professors). PhD in Public law (University of Bologna, 2001). He was Project leader in a project for training and research funded by the European Commission - OLAF for the administrative fight against corruption (Hercules program, 2016-2018, "Fighting corruption through administrative measures"), and director of the "winter school" linked to the Project (winter 2017-2018). Since 2017 he's "Expert of the Council" of the Italian National Anti-Corruption Authority. He was senior expert for the Ecole Nationale d'Administration - ENA, in the framework of a European project "twinning" support to the administrative modernization of Albania (2015-2016), and a legal expert for the Department of Cohesion - National Authority anti-corruption, as part of a study group for the definition of indicators for combating and preventing corruption (2015-2016). He was involved in a project of the University of Barcelona on the contrast to administrative corruption, and recently involved in a research project of national interest on the economic crisis and administrative reforms (University of Perugia). He is currently Professor of Law Regional and local governments, open government and digital administration, institutions of administrative law. He was a visiting professor and visiting lecturer at the University of Barcelona and UOC at the University of Giessen. He has participated in several research projects of national interest, in particular in the fields of: eGovernment, administrative transparency (Prin 2004), information of the public administrations, as well as public health and efficiency of public administrations (FIRB 2001), and has been responsible of the unit of Perugia within a project of national interest with regard to university autonomy (Prin 2007). He was a speaker at over one hundred conferences and seminars in Italy and abroad. He is a member of the coordinating group of San Martino between scholars of administrative and public law. He is the author of four monographs and more than one hundred publications in various fields of administrative and public law. Finally, he published the volume "Corruzione e anticorruzione. Dieci lezioni" with Raffaele Cantone (Feltrinelli ed., 2018).
