I have been regularly teaching in a full-time regime since 2006 for a total of almost 20 academic years thus far. I usually teach two courses (9 CFU each) both at the bachelor and master level with 18 CFU per year. At the Univ Perugia I regularly teach, both in Italian and English, International relations and Global politics to Bachelor and Master students. Previously I have also taught Political Science, Comparative Politics, and Public Policy Analysis.

I supervise 6-7 Master and Undergrad theses per year in political science, international relations, comparative politics and public policy analysis, for a total of more than 120 theses until now.

I also teach abroad – usually in the language of the relevant country – during my visiting periods and/or my Erasmus Teaching periods (see also section E). I also hold Phd Courses and I have been supervising 7 PhD thesis, currently supervising 2 on the topic of quality of local democracy and the role of emerging technologies in the government crisis management.
