## Stefano Giubboni *Curriculum vitae*

Stefano Giubboni is currently full professor of labour law at the Department of Political Sciences of the University of Perugia. Formerly an associate professor at the Faculty of Law of the University of Florence between 2002 and 2007 and at the Department (previously Faculty) of Political Science of the University of Perugia up to July 2018, he also held courses on EU labour law and social security law at the Universities of Urbino "Carlo Bo", Macerata, Milan, at LUISS "Guido Carli" and at the University of Catania. Furthermore, he held courses on EU and international labour law at several foreign universities (Santiago de Chile, Buenos Aires, Maputo, Antwerp).

After graduating in law from the University of Perugia in 1991 with a thesis that earned him the *Premio Barassi* award, and having graduated from the School of Specialization in Labour and Social Security Law at the University of Macerata in 1996, in 2002 he achieved a Ph.D. in Laws the European University Institute in Florence, where he has been a researcher since 1996 and where he was Professor Silvana Sciarra's research assistant in 2000 and 2001. In 2007 he was a visiting scholar at Columbia Law School; in 2010 a *Dickinson-Dees Fellow* at the University in Durham; in 2014 a visiting professor at the University of Antwerp. In 2016, he was first a research fellow at Fordham Law School in New York, then a *Fernand Braudel Senior Fellow* at the Law Department of the European University Institute in Florence.

He is a member of the board of directors of the *Rivista del Diritto della Sicurezza Sociale* and has been co-editor in chief of the *European Journal of Social Law*, published by the Belgian editor La Charte between 2011 and 2014. He is a member of the editorial board of the *Giornale di diritto del lavoro e di relazioni industriali*, founded by Gino Giugni, and a member of the board of directors of the *Rivista critica del diritto privato*, founded by Stefano Rodotà. Moreover, he is member of the advisory board of the *Rivista giuridica del lavoro e della previdenza sociale*, of *Politiche sociali/Social policies* and a member of the evaluation committee of *Costituzionalismo.it*, *Rivista italiana di diritto della sicurezza sul lavoro – Rivista dell'osservatorio Olympus*, of the advisory board of the *Rivista degli infortuni e delle malattie professionali*, *Informazione previdenziale*, *Immigrazione.it*, *Terzo settore*, *non profit e cooperative – Rivista trimestrale di diritto e pratica degli enti e società senza scopo di lucro*, and *La Previdenza Forense*. Since 2014, he has been in the editorial board of *Menabò di Etica e Economia*. He is the coordinator for labour law of the *Libro dell'anno di diritto*, published annually since 2011 by *Istituto della Enciclopedia Italiana fondata da Giovanni Treccani*.

He has participated as a speaker in several national and international conferences and workshops and, since the late 1990's, has taken part in numerous European projects and research networks (among which TRESS and FRESSCO in relation to the free movement of persons and on the coordination of social security systems). He has been appointed several times as an expert in the field of EU social security law by the European Commission, the European Economic and Social Committee and by the European Parliament.

He has written extensively on labour law and social security law, especially from a European and comparative perspective; among his main publications the following can be mentioned *Diritti sociali e mercato*, II Mulino, Bologna, 2003; *II diritto della sicurezza sociale in trasformazione* (with Maurizio Cinelli), Giappichelli, Turin, 2005; *Infortuni sul lavoro e malattie professionali* (with Aldo De Matteis), Giuffrè, Milan, 2005; *Social Rights and Market Freedom in the European Constitution*, Cambridge University Press, 2006; *La libera circolazione dei lavoratori nell'Unione europea* (with Giovanni Orlandini), Il Mulino, Bologna, 2007; *La previdenza complementare tra libertà individuale* 

ed interesse collettivo, Cacucci, Bari, 2009; Diritti e solidarietà in Europa, Il Mulino, Bologna, 2012; Infortuni sul lavoro e risarcimento del danno (with Andrea Rossi), Giuffrè, Milan, 2012; Infortuni sul lavoro e malattie professionali (with Giuseppe Ludovico and Andrea Rossi), Cedam, Padua, 2014 (second edition 2020); Cittadinanza, lavoro, diritti sociali. Percorsi nazionali ed europei (with Maurizio Cinelli), Giappichelli, Turin, 2014; Diritto del lavoro europeo. Una introduzione critica, Wolters Kluwer Cedam, Milan, 2017; Lineamenti di diritto della previdenza sociale (once again with Maurizio Cinelli), Wolters Kluwer Cedam, Milan, 2018 (second edition 2020); Anni difficili. I licenziamenti in Italia in tempi di crisi, Giappichelli, Turin, 2020. Moreover, he has recently edited Le parole del lavoro, a book for secondary school students (Istituto della Enciclopedia Italiana, Rome, 2019), and the legal commentary Reddito di cittadinanza e pensioni: il riordino del welfare italiano (Giappichelli, Turin, 2020).

As a practising lawyer he has been a member of the National Scientific Committee for AGI – *Avvocati Giuslavoristi Italiani* from 2013 to 2016 and, up to 2019, he was vice-president of the regional branch of the Association for Umbria. He is president of the regional section for Umbria of the *Centro nazionale di studi di diritto del lavoro* "Domenico Napoletano, as well as secretary for the Italian section of the European Institute of Social Security; moreover he is a member of AIDLASS – *Associazione Italiana di Diritto del Lavoro e della Sicurezza Sociale* and of AISRI – *Associazione Italiana per lo studio delle relazioni industriali*, a member of the *Movimento Europeo Italia* and of ELI – European Law Institute.

Since 2015, he has been vice-president of the Fondo di solidarietà per la riconversione e riqualificazione professionale, per il sostegno dell'occupazione e del reddito del personale del credito (Solidarity fund for professional retraining and re-qualification, for the employment and income support in the banking sector) at INPS – Istituto Nazionale della Previdenza Sociale.

He is currently a legal consultant of the Italian Ministry of Labour and Social Policies.
